Obtain an attorney for legal advice on various matters. Development of a Budget for the upcoming year.

Treasures Report: Jeanette reported of the Income and Expenses of the past year.

Reported on Dues shortcomings (unpaid dues).
Reported on the established Budget of October 21, 2006.
Primary expenses were winter snow removal and weed spraying this year. See attached Report for the specifics of the Financial Report.

Secretaries Report: Bob gave a brief on the four Board meeting that took place in the past year. Three of which were conducted via conference call.

Primary subjects of all meetings were Road Maintenance and Dues collection.

Vice President: Wes Haws spoke at length on the issues of snow removal of this past winter, why weed spraying and clearing was not accomplished last year. He also spoke to the costs of graveling the primary 'hot spots' and the costs to be incurred. Basically, the Association does not have enough money to gravel all areas because of lack of funds due to the amount of unpaid Dues.

How to retrieve unpaid Dues and why are there unpaid Dues.

One-time assessments to generate Emergency fund for major road repairs, such as from washouts.
